**Booth Size: 12x12 feet ~ Application deadline: July 1**

**Hours of Operation: 9:00 AM to 4:00 PM**

**Set Up and Parking: Set up is from 6 to 8:45 a.m.** This is a park venue. Please do your best to utilize the site to its fullest potential. Please note: Please be considerate of wheelchair, baby carriage and disabled persons access.

**You must have your booth set up to be open, with your vehicle parked in an off-street parking lot by 8:45 a.m.** Your booth space(s) and parking options will be marked on the venue map which will be e-mailed to you with you by August 1. Close-in street on parking is not allowed as these valuable parking spots are reserved for buyers and visitors! Please do not block crosswalks OR doorways at ANY time.

**You are expected to stay open for business until 4 p.m.** Thank you.

**Standards:** Selection of food vendors will be made on the basis of quality and pricing, with the priority of providing a variety of menu choices for the Art Show. The Moore Park Art Show does not grant vendors exclusive rights to sell any particular item. Duplication of items will be avoided, but is not guaranteed. Vendors must list on their application all items and services which they wish to sell. Vendors may not share booth space. Each business or organization must apply for booth space separately.

**Electricity:** 110 power is limited to certain booth areas. Please indicate on the application if you need electricity. Vendors must bring suitable cords and outlet strips to meet their needs.

**Waste disposal:** Food Vendors will not be able to dispose of grease on site. Moore Park Art Show provides 1 dumpster. **YOU WILL BE EXPECTED TO PUT YOUR TRASH INTO THE DUMPSTER WITHOUT OVERFLOWING IT. ANY EXCESS MUST BE REMOVED BY YOU.** Thank you for your cooperation in taking care of our beautiful park!
